WE USE A LIVE-IN HOUSE PARENT MODEL WHICH PROVIDES THE CHILDREN WITH CONSISTENT CAREGIVERS AND FAMILY STYLE LIVING. ALL DIRECT CARE STAFF ARE TRAINED IN TRAUMA-INFORMED CARE TO HELP THE CHILDREN BEGIN TO HEAL FROM THE TRAUMA THEY'VE ENDURED. TOGETHER WITH OUR COMMUNITY PARTNERS, A KID'S PLACE OFFERS COORDINATION OF SERVICES, MEDICAL, DENTAL AND THERAPEUTIC CARE AS WELL AS LIFE-SKILLS EDUCATION. ONSITE EDUCATIONAL PROGRAMS INCLUDE A HILLSBOROUGH COUNTY ELEMENTARY CLASSROOM, PRE-SCHOOL PROGRAM AND TODDLER CLASS.

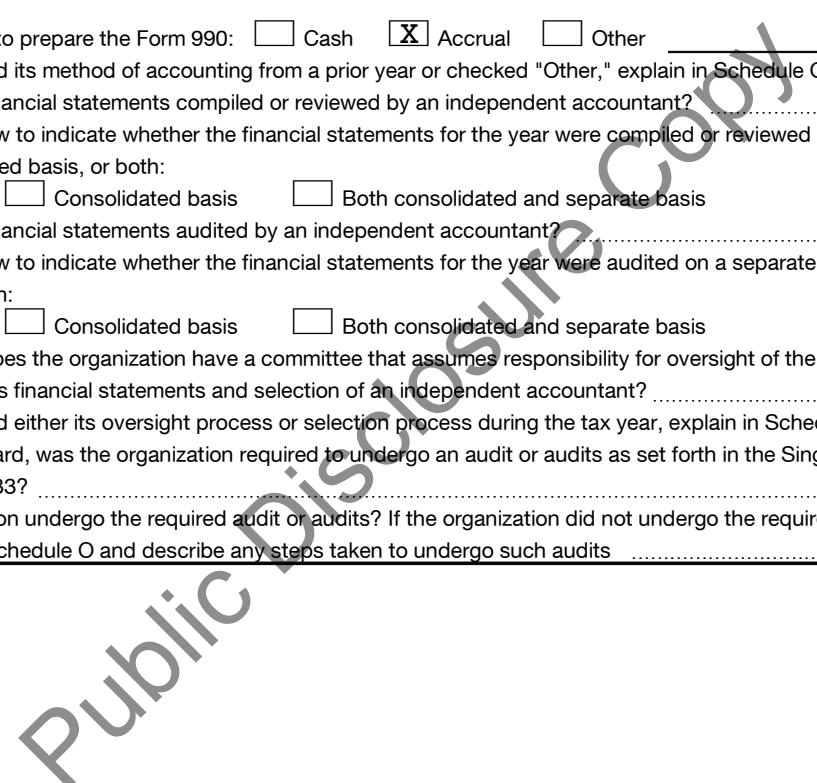

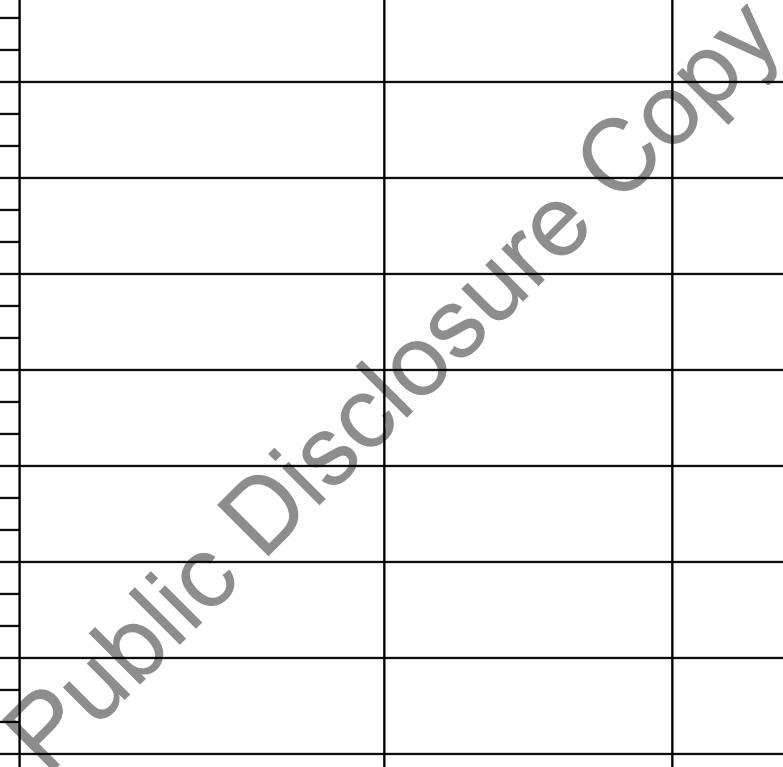
